ELIGIBILITY

Eligible boats may enter by completing the online registration form and making the required payment prior to midnight CDT **Monday, Oct 11th**.

Entrants shall select to sail in the Championship, Challenger or Non-Spinnaker Fleet when registering, except that the winner of the Challenger Division in the last two years must sail in the Championship Division.

RULES

This regatta is governed by the rules as defined in the *Racing Rules of Sailing* (RRS). RRS Appendix V, Alternative Penalties, shall be in effect. *Sailing Instructions* will be posted online and will be available at check-in.

CREW CHANGES	Crew changes will not be allowed after the first race without the approval of the regatta chairperson.
